## Mission

## Purpose

The purpose of this donations policy is to outline the guiding principles relating to all activities intended to generate funds for the work of FAIN.

## Definitions

<i>Donation</i>	money gifted and transferred with no material benefit or advantage for the donor.
<i>Donor</i>	an individual or their legal representative (in the case of a deceased person's bequest) or other entity that makes a donation to a cause.
<i>Fundraising</i>	the act of seeking and obtaining donations on behalf of a cause.
<i>Sponsorship</i>	money given in support of our fundraising in return for a benefit of value.

Consumer Affairs Victoria 'regulates the majority of fundraising activities in Victoria and oversees the laws that govern fundraising across the state – *Fundraising Act 1998 (Vic)* and *Fundraising Regulations 2009 (Vic)*.'

## Policy Statement

Within Victoria FAIN complies with the general conduct requirements of the Fundraising Act 1998 and in line with FAIN best practice and our fundraising practices based on honesty, integrity, accountability and transparency. This policy applies to all our volunteers.

FAIN is not required to register under the Fundraising Act 1998 (the Act) to conduct fundraising appeals, but must otherwise comply with all the requirements of the Act, if they:

- receive less than \$20,000 gross in a financial year from fundraising
- are not paid for conducting the fundraising, and
- use only unpaid volunteers.
